A resident asked if there was a noise ordinance for the day time as well as the night time.

Deputy Thomas said yes, anytime the noise is bugging you call.

They encouraged the use of their [valuables envelope](#) which is an envelope for your valuables with a list on it.

A resident asked what is the procedure if the sheriff gets called out on an alarm to a house and the house has a locked gate.

Deputy Thomas stated that they checkout the front area and they do not encourage jumping over the fence.

He said to give the code to your alarm company and they would wait until you got home.

A resident asked if they had a way of alerting the neighbors about a burglary in the area.

Deputy Thomas stated that they drive house to house to alert them.

Another resident then stated that they saw a neighbor's house get burglarized and that they were not informed. They also stated their concern for vacant homes in the area.

Deputy Thomas said they patrol the areas in unmarked sheriff vehicles at random intervals.

A resident asked how effective a gate is for security.

Deputy Thomas said somewhat, but if someone wants in they will get in.

A resident asked for some information on the crime survey.

Speaker 4 – General Plan Update Continued

George said that in place of the mid-county parkway, they are replacing it with the [Cajalco expansion project](#).

There will be a 150 ft road going in and that they are calling it a 4 lane road with a 2 lane island for future expansion.

George told us that there used to be a village under Lake Mathews, it was named *Kaxalco* meaning place for quails.

He said that [proposal 2](#) was not in the [General Plan](#) however the EIR might include it.

George stated that the [EIR](#) was 18 months out from now and should be ready for review in summer 2012. He stressed the importance for legal counsel to examine these documents and to have them ready in advance as we will only have 45 days to look at it.

George is on the committee concerning the [General Plan](#) and the last met in September 2009 and do not meet again until June 2011.

He said that the [General Plan](#) is like the constitution for our county.

He stated that the Mid-County parkway does not fall on any one group, this affects many and many groups brought money to fight for this cause.

George stated that the route that goes down the existing route should be less damaging to the environment.

He said that if the existing route was chosen that WMWD would have to open their conservation plan and take another look at it.

George did say that the county does not have the right of way yet on the east side of the 215.

He said that they need to have something in place by 2014 or they will revisit the mid-county parkway.

The county originally wanted to have multiple EIR's for the project but George stressed the importance for one [EIR](#) on the whole project for environmental reasons so they are currently going with one.

A resident stated that Juan Perez from the planning department said it would be done in sections. George said he would call him and verify that it is still one.

(George contacted me a day later and did confirm the single EIR)

A resident asked why the county needs this parkway.

George mentioned that March Air force Base is going to be used as a shipping hub.

The Riverside County Plan was approved in 1987.
